- Who should take the CPBM Certification **COURSE**? Any forest land owner, forester, wildlife biologist, consultant, contractor, or agency personnel who is interested in the use of prescribed wildland fire as a management tool and who is seeking certification should attend. Out of state participants are welcome.
- Who should take the CPBM recertification **WORKSHOP**? Any current Alabama Certified Prescribed Burn Manager who needs the required 6 CEU every 5 years for re-certification should take the workshop.
- These courses/workshops are sponsored and partially funded by the Alabama Forestry Commission. Due to a reduction in government grant funding there is a registration fee to partially cover the cost of the courses and workshops.
